- A. The prices will include all work, including furnishing all labor, materials, equipment and services. The prices listed below shall include all labor, materials, direct and indirect costs, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit.
- B. VALUE ADDED TAX The Contractor shall include VAT as a separate charge on the Invoice and as a separate line item in the bill of quantity.
- C. The contractor shall prepare his own bill of quantity (BOQ) from the site visit.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1.0 INTRODUCTION

1.1 The U.S. Embassy in Sofia has a requirement to obtain the services of a contractor to renovate a kitchen in the residence at #25A Trichkova Mogila St, Boyana. The contractor is required to visit the locations as all measurements are approximations and should be field verified by the contractor before submitting their bids.

2.0 GENERAL REQUIREMENTS:

2.1 The work shall be executed in a diligent manner in accordance with a negotiated firm fixed price and performance period. The period of performance for the project shall be 30 working days for the pre-fabrication of the cabinets and 3 working days for the installation. Work shall be performed during regular working hours. The contractor shall not have access to the building interior, other than work site.

2.2 The contractor shall be required to prepare his own bill of quantity (BOQ) from the site visit and provide dimensions of the elements indicating for example, rates in square meter or linear meter, along with the quality control schedules and sketch/conceptual design. The sketch/conceptual design developed by the contractor shall be in line with the ones supplied by the embassy. These documents shall provide the necessary interfaces, coordination, and communication among the Embassy and contractor for the delivery of the completed project.

3.0 SCOPE OF WORK (SOW):

3.1 The contractor shall be required to prepare a price and indicate the bill of materials [BOM] and all product data of all materials to be used on the project. The BOM's shall list the materials in sufficient detail and specifications, so that this document can be used by the Embassy to approve the use of all materials along with presented samples.

3.2 Logistics: Staging/storage areas available on grounds

3.3 Materials and equipment:

All materials, equipment, tools required for the satisfactory completion of the project shall be considered to be included and accounted for by the contractor.

3.4 Labor:

All skilled labor required for the satisfactory completion of the project shall be considered to be included and accounted for by the contractor.

3.5 General scope:

1. Supply and install new wooden kitchen cabinets, as per the attached conceptual sketches/drawings.
 - The doors of the kitchen cabinets shall be fabricated using high quality oak or walnut solid wood.
 - The corps of the cabinets to be made of MDF panels 20 mm with natural veneer oak or walnut

- The cabinets to be finished with high quality semi-gloss wood varnish. All accessories used for the kitchen like hinges, handles, door closers and accessories shall be high quality stainless steel made in US/UK/Germany/Italy. Sample of finished wood and accessories shall be supplied by the contractor for Embassy review and approval.
2. Supply and install new 20 mm natural-stone kitchen counter top, 38 mm front face. Provide and install 20 mm natural stone panels on the wall between upper and lower cabinets and interior windowsill made of the same material
 3. Supply and install new high quality stainless steel sink 420,600,210 mm, Franke, Teka or equivalent.
 4. Provide and install new kitchen faucet Franke, Teka, Ikea or equivalent with retractable pull-out wand, as per approved sample
 5. Provide and install new high quality kitchen hood, 90 cm wide, preferably GE, US brand or equivalent. The recommended brand and specifications of the kitchen hood are as below:

General Electric Brand, Model JV731 SIG SB, JV 130 SIG SS, Motor 190 Watts, Lamp 20x20 watts, breaker amps: 20; CFM 600, Size 36"x13"11 ½ "/ 23 ½"12"x 11 ½"

6. Supply and installation of LED lights under the wall cabinets, the sample shall be approved by the COR. Run electrical wiring and make connections as necessary. The LED light installed shall be daylight and shall be UL/CE classified and shall have a warranty of two years. Wiring for the kitchen appliances and lights will be a subject to another contract
7. General requirements
 - Contractor shall provide/install anything else not mentioned above but necessary to ensure a satisfactory completion of the project and in line with on-site instructions received from the Embassy / Contracting Officer's Representative (CO) / Post Occupational Safety and Health Officer (POSHO /authorized representatives.
 - All associated work required to successfully complete the above work shall be carried by the contractor.
 - Contractor shall be required to take measurements of the room size during the site visit and provide drawing/sketch of the project based on the actual measurement and information provided by the embassy.
 - All sample of products/materials used for this project should be submitted for review and approval. Product data/catalogs of products shall be provided when actual sample can't be provided. The bids will not be technically qualified if complete products or products details are not included with the proposal.

Experience/Past performance:

- Provide a list of similar and other projects/contracts previously performed and points of contacts with phone numbers.

Warranty

- 5 years on the installed cabinets, accessories, glasses, granite kitchen counter top and tiles.
- 2 years on the kitchen hood, kitchen sink, faucet and LED lights.

- All debris/materials/trash removed from this project shall be disposed of by the contractor as per local government's law/guidelines.

3.6 Anything else not mentioned above but necessary to ensure a satisfactory completion of the work and in line with onsite instructions received from the Embassy / Contracting Officer's Representative (COR) /Post Occupational Safety and Health Officer (OSHA)/authorized representatives.

3.7 **Cleaning:**

Clean area of work and restore all items to their existing conditions at the end of each day as long as they do not affect the next day's progress. The work site shall always be kept clean and clear of obstructions as the surrounding area shall be in use and the work should pose the least impact upon the general day to day use of the property.

4 **CONTRACT ADMINISTRATION:**

- 4.1 The Embassy does not make representations or warranties of whatsoever kind or nature, either expressed or implied, as to the quality, level of completion, accuracy, extent of compliance with the standards, codes and requirements described or referred to in this SOW, or the extent of coordination between or among the documents provided to the contractor.
- 4.2 The Embassy has the right to inspect and test all services called for by the contract, to the extent practicable at all times and places during the term of the contract. The Embassy/COR/OSHA will perform quality assurance inspections [QAI] and tests during installation to confirm the work is installed according to the SOW.

5 **RESPONSIBILITY OF THE CONTRACTOR:**

- 5.1 The contractor shall be responsible for the professional quality, technical accuracy, and the coordination of all construction and other services furnished under this contract. The contractor shall, without additional compensation, correct or revise any errors or deficiencies in provided services to the satisfaction of the Embassy/COR/FAC/OSHA.
- 5.2 The contractor shall identify a Project Site Manager who shall be responsible for the overall management of the project and shall represent the contractor on the site during construction. The Project Site Manager shall speak English.
- 5.3 The contractor is responsible for safety and shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety and similar matters. The contractor shall promptly report all accidents resulting in lost time, disabling, or fatal injuries to the Embassy.
- 5.4 The Contractor shall be and remain liable to the Embassy in accordance with applicable law for all damages to the Embassy caused by the contractor's negligent performance of any of the services furnished under this SOW.

6. **GENERAL INFORMATION:**

6.1. All work will be done during working days, Sunday to Thursday, 0830-1630, except as advised by the Embassy/COR/POSHO or his authorized representatives. List of workers, vehicles and equipment involved in the project must be submitted to the COR two weeks prior to starting the project.

6.2. The Embassy is closed during American Federal Holidays and Bulgarian holidays. The contractor shall not work on these days unless specifically requested.

7. SAFETY:

All required safety procedures are to be followed. All workers must wear appropriate safety personal protective equipment to include safety shoes, safety glasses, safety masks, head protection, body harness etc. Keep the work-site secured, and clean-up all debris and trash at the end of each workday. The contractor shall never leave power equipment unattended without disconnecting them from their power source. All tools, electrical extensions, materials if any used for this project shall be inspected by the COR/POSHO or his/her authorized representatives and they are to be stored in a location designated by the Embassy/COR/POSHO. The work site shall always be secured/barricaded until the project is completed.

All necessary safety precautions, barricading the area with appropriate signage will be installed by the contractor to protect the pedestrian traffic, which includes work site, surrounding and staging areas.

Contractor must use protective clothing when working inside the kitchens. All items in the kitchens or the work site shall be secured by the contractor from dirt, debris or any other damages. It is the responsibility of the contractor to clean the residence of any dust, debris, trash if any from the construction. All affected area shall be cleaned by the contractor as appropriate or as directed by the COR/Embassy.

8. INSPECTION & ACCEPTANCE:

The project and services being performed and tools/supplies used to accomplish the project will be inspected by the Embassy/COR/POSHO or his authorized representatives to determine that all the work is carried out in a satisfactory manner and that all the tools and equipment used to complete this project are of acceptable quality and standard. The contractor shall be responsible to immediately remedy any unacceptable work or conditions within the scope of work of this project.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.
